

## **Pet Rules Lease Addendum**

1. A maximum of two pets are permitted per apartment. All cats must be spayed or neutered, and declawed. Small mammals, such as rabbits, chinchillas, or guinea pigs must be caged.
2. There will be a \$15.00 per month pet fee added to the monthly rent for each pet. A copy of these rules signed by Tenant must be delivered to Landlord prior to bringing the pet onto the premises.
3. Pets are not permitted to “visit” the premises without first complying with Provision 2, even if only temporarily visiting.
4. Landlord reserves the right to determine at its sole discretion which, if any, pets may be kept, and may require removal of pets for any reason whatsoever. Landlord may establish specific additional requirements for specific pets, which shall be deemed part of these rules.
5. Pets must be carried in Tenant’s arms, pet carrier or other container at all times in hallways, stairs, lobbies or other common areas inside the building. Pets must be on a leash at all times on the outside premises, and may not be left unattended for any length of time.
6. All pets must be completely housebroken. Litter must be changed as frequently as necessary to assure sanitary and odor-free conditions. Litter must be properly disposed of in a securely tied plastic trash bag. Tenant must carry provisions for immediate clean up and disposal of any mess which the pet may make outside.
7. Pets must receive regular veterinary care, including immunizations and vaccinations as appropriate for the specific animal. Upon request of Landlord, Tenant shall provide written proof of such care to the satisfaction of the Landlord. Tenants must be in full compliance at all times with all state, county and city ordinances, and health department and police department requirements regarding the care and treatment of animals.
8. Pets must be trained not to make noise that can be heard outside of the apartment. After one warning, continued complaints may cause Landlord to require the removal of the pet(s) from the premises.
9. Please provide a picture of your pet(s) to our office to assist management in returning lost pets to their owners.
